#### 1 Terms and conditions

#### 1.1 The Promotion

- (a) These terms and conditions and the Entry Details govern the Promotion.
- (b) Win a Trip to Italy
- (c) The Promotion will commence on the Start Date and close on the End Date (**Promotion Period**).

[The Promotion is authorised under the Permit[s] T23/1971

## 1.2 Eligibility

The Promotion is open to any individual who meets all the following criteria (each, an Entrant):

- (a) the Qualifications for Entry;
- (b) The individual purchases a food or beverage from the promotor during the promotional period
- (c) The individual is not involved in conducting the Promotion or the management of any benefiting business in relation to the Promotion; and
- (d) The individual is not employed by the Promoter or related in any way to an existing employee of the Promoter.

### 1.3 The Prize[s]

- (a) The Prize is not exchangeable or redeemable for cash or other goods or services, and may not be resold or offered for resale at a premium (including via online auction sites) or used for advertising, promotion or other commercial purposes

- (g) Any entry not in compliance with these terms and conditions is automatically invalid. The Promoter reserves the right to accept or reject non-compliant or incomplete entries in its sole discretion.
- (h) Each Entrant is responsible for any expenses incurred in relation to participating in or winning the Promotion. An Entrant will not be reimbursed for any cost incurred in the event of winning the Promotion other than as expressly set out in these terms and conditions.
- (i) An Entrant or purported Entrant will be disqualified from the Promotion, and will not be eligible for any Prize, if they:
  - (i) enter the Promotion without being eligible under clause 1.1(a);
  - (ii) tamper with the entry process, including by using bots or other automatic or illicit means to enter the Promotion;
  - (iii) submit an entry that does not comply with these terms and conditions;
  - (iv) engage in misleading, deceptive or fraudulent conduct, or otherwise behave in a way that may (in the Promoter's opinion) bring the Promoter into disrepute; or
  - (v) are unable to furnish proof of purchase in accordance with clause (e)].
- (j) Entries must be received before the draw is conducted in accordance with clause 1.4.

#### 1.4 The Draw[s]

- (a) The Promoter will randomly draw the winner of the Promotion from the pool of valid entries made by Entrants during the Promotion Period by random at the draw date
- (b) The Draw will take place at the Draw Location on the Draw Date
- (c) Each valid entry in the Draw will have an equal chance of being drawn.

## 1.5 Notification of Winner[s]

Within [7] days after the Draw, the Winners will be contacted by Instagram and email.

#### 1.6 Publication of Winners

(a) Within [30] days after the Draw, the Promoter will announce the Winner[s] of the Promotion in the Publication.

#### 1.7 Prize distribution

#### 1.8 Prize substitution

## 1.9 Rejection of [the/a] Prize

#### 1.10 Unclaimed Prize

- (a) If the Prize is is not able to be claimed by the Winner through no fault of the Promoter within a period of 14 days after the Draw Date (Claim Period), the Prize will be deemed forfeited and the Promoter may redraw the Prize in accordance with clause 1.11].
- (b) The Promoter will make every reasonable effort to contact the Winner during the Claim Period.

#### 1.11 Redraw

(a) In the event that the Prize is rejected in accordance with clause 1.9(a) or unclaimed in accordance with clause 1.10, a second draw for the Trip to Italy (Redraw) will take place on

the Redraw Date, and the Redraw will be deemed a Draw and the Redraw Date will be deemed the Draw Date for the purposes of clauses 1.4, 1.10 and 1.14 of these terms and conditions.

(b) The Redraw will take place at the Redraw Location.

## 1.12 Promotion

- (a) The Winner[s] consent[s] to the Promoter, without royalty or any fees, using his or her name, likeness, image, voice and entry in any marketing and promotion of the Promoter and/or business.
- (b) The Winner[s] may be required to participate in media activity and sign a release and consent form if requested by the Promoter.

## 1.13 Dispute resolution

  - (iii) any theft, destruction, unauthorised access to or alteration of entries; or

### 1.16 Force majeure

Without limiting clause 1.14, if the Promotion is unable to proceed due to unforeseen circumstances, including cyber-attack, industrial strike, computer virus, fraud, or technical failures, the Promoter may take appropriate action with respect to the Promotion (including suspension, termination or modification of the Promotion) as it deems appropriate, subject to any relevant regulation or law or direction from a regulatory authority.

#### 1.17 Privacy and personal information
